

**List of Decisions of the 33<sup>rd</sup> GA**  
**hosted by IWO/Better World in South Korea**  
**15-21 October 2014**

The 33rd General Assembly of the CCIVS was celebrated in Seoul, South Korea. There were 38 organisations with voting rights: 30 presents and 8 proxies, from members in Africa, America, Arab states, Asia and Europe.

The lists of decisions are not the official minutes of the General Assembly, but a first document to have members informed about the main decisions and flow of the GA. The official minutes will be shared at a later date.

The GA brought together many representatives of IVS organisations from across the globe; it provided a rich platform for exchange and debate. CCIVS members worked together to respond to the needs of the network and to clearly define the future plan of action.

**1. Adoption of the [President Report](#)**

The report included points on the objectives to be attained such as improving the management system of the secretariat; to reduce the debts of CCIVS; to build a sustainable team in the Secretariat; to improve internal and external communication; to promote CCIVS membership; to develop new communication tools; more visibility events (CCIVS day) and to build relations with build relationship with other networks (Alliance and SCI), other institutions (UNV, CoE...)

**2. Adoption of the [Activity Report](#)**

The report provided an overview of the different projects developed 2013-2014 and new projects approved, such as Impact, WHV, Social Inclusion Seminar, Global meeting of the IVS networks, Global LMTV meeting, Raising Peace (peace and human rights) campaign, Vision to Action (sustainability) and Contact to participation (meda). The report also focused on external partnerships and provided some statistics.

**3. Adoption of the REGIONAL REPORTS BY THE FOCAL POINTS**

CCIVS needs to further develop actions and projects in Mediterranean area

### 4. Adoption of the [Treasurer Report](#)

The Result in 2013 with 23 000€ surplus (as was planned), a thank you to the members who have supported CCIVS by accepting late repayments, providing donations and loans. The Financial management system is improved.

### 5. Adoption of the [Internal Auditor's Report](#)

Significant effort in straightening the records of balance by CCIVS and its members; new tools: everyday management and project-related sheets; open and transparent communication: information about results of current year, about EC expenses and about outstanding debts; positive result and yet cautious reporting (provision of risk); recommendations: check and balances once a year with each member – no more cash payment

### 6. Adoption of the [Policy Paper on quality and membership](#)

Proposal to monitor quality improvement in IVS and for the minimum requirements to become a member of CCIVS

### 7. Adoption of the modifications to the [Constitution](#)

There are some questions concerning the legal language of the document – any suggestions for modifications need to be submitted 6 months prior to the GA.

### 8. Adoption of the paper [Guidelines for participation of nonmember organisations in CCIVS activities](#)

The CCIVS EC drafted a paper in order to provide clear guidelines concerning the above.

### 9. Adoption [paper for EC Guidelines](#)

The GS introduced this proposal as a supporting document for EC members about their role, tasks, and financial conditions. It clarifies the practices and management of this
